It has been decided with the prior approval of competent authority that as a result of this decision of the State Government, it is hereby notified that 10% reservation would be provided for Economically Weaker Sections and 5% reservation would be provided for Persons With Disabilities (PWDs) in Educational Institutions for the purpose of admission in various courses on or after issuance of these instructions. The benefit of reservation under Economic Weaker Section (EWS) and Person with Disability (PWDs) can be given as per the reservation roster given at Annexure-A and Annexure-B.
