## UNDERTAKING

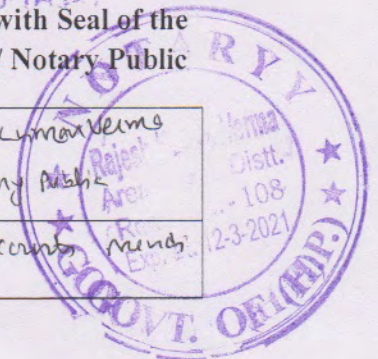
